J. Butler, of the County of Greenville, in the State of South Carolina, for and in consideration of the sum of Four hundred Dollars, to Robert B. Montgomery in the State of South Carolina (the receipt whereof is hereby acknowledged,) have granted, bargained, sold and released, and by these Presents, DO GRANT, bargain, sell and release unto the said Robert B. Montgomery all that certain

piece, parcel or lot of land situate lying and being in Greenville Township in the County and State aforesaid. Beginning at a stake 122 rods distant from the original R. O. corner and on the line (formerly Mrs. Owen's) now Mrs. E. K. Mauldin's land running thence N 72° E 31.30 to stake 3x on said line corner of John Austin's former tract thence S 42° 9' chains to a stake and thence corner of the same thence S 77° W 11.5 to a Persimmon s.x. thence S 61° W 7.21 to a R. O. Sapling thence N 12° 2.22 to the beginning containing (14) fourteen acres more or less and being the same tract of land conveyed to me by Preston Moulton by deed bearing date the 11th day of September A. D. 1883 recorded in Book "C O" in the office of the R. M. C. for Greenville County at page 534.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said Premises before mentioned unto the said Robert B. Montgomery His Heirs and Assigns forever.

AND I do hereby bind myself and my Heirs, Executors and Administrators, warrant and forever defend all and singular the said Premises unto the said Robert B. Montgomery His Heirs and Assigns, against myself and my Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
