Woodside Register, Misne Conveyance in the State, aforesaid; to have hold, exercise and enjoy the said office of Register, Misne Conveyance in and for Greenville County, together with all the rights, privilege, profits and emoluments, whatsoever thereto belonging or in anywise appertaining. This Commission to continue in force until the next general election and until your successor shall qualify. Given under my hand, and the Seal, of the State, in Columbia this 26th day of January in the year of our Lord, one thousand eight hundred and eighty nine, and in the one hundred and thirteenth year of the Independence of the United States of America. Greenville S.C. January 23rd 1889 I do solemnly swear that I am duly qualified according to the Constitution of the United States and of this State to exercise the duties of the office to which I have been appointed and that I will faithfully discharge to the best of my abilities the duties thereof that I recognize the supremacy of the Constitution and laws of the United States over the Constitution and laws of any State and that I will support protect and defend the Constitution of the United States and the Constitution of South Carolina as satisfied by the people on the sixteenth day of April 1868.

I do solemnly swear that I have not since the first day of January A. D. 1881 engaged in a duel within or without the State, either as principal or second or been present thereof as a party thereto in behalf of either the principal, in such duel and that I will not during the term of office to which I have been appointed engage in a duel as principal or aid and a bet in such duel a second or as a party thereto in behalf of either principal or otherwise.

I Thomas L. Woodside do further swear or affirm that I am under no promise in honor or law that I have the profits of the office to which I have been appointed, or elected, as the case may be, and I will not directly or indirectly sell or dispose of said office or the profits thereof but will resign or continue to discharge the duties thereof during the period fixed by law if so long live as help me God sworn and subscribed before me this 23rd day of January 1889.

Whereas James W. Goldsmith of Greenville County in said State departed this life in the year 1877 leaving of force his last will, whereby he appointed Sarah E. Goldsmith and D. V. Anderson executrix and executor thereof; and whereas the said Sarah E. Goldsmith duly qualified as executrix thereof but D. V. Anderson never qualified; and whereas the said James W. Goldsmith in and by said directed and empowered the executor to sell such of his real and personal property as might be necessary to pay his debts, and devised and bequeathed all the residue of his real and personal estate to the said Sarah E. Goldsmith; and whereas the said James W. Goldsmith at the time of his death was thrown out of the track of land hereinafter described in fee simple; and whereas there are still debts against said estate and the said Sarah E.
