 of Greenville in Greenville County and State aforesaid  
 it being the lot purchased by me from R M Pickens fronting  
 on Lloyd Street sixty feet and running back two hundred and  
 eighty six feet adjoining R M Pickens Mrs Charlotte Bardine  
 and Methodist Protestant Church lot.  
 Together with all and singular the Rights, Members, Hereditaments  
 and Appurtenances to the said premises or in anywise incident  
 or appertaining, To have and to hold all and singular the  
 said premises before mentioned unto the said G M Monroe  
 Pickens and Chesley B Pickens their Heirs and assigns forever  
 Provided That the said premises together with the Rights, Members,  
 Hereditaments and Appurtenances thereto or in anywise incident  
 or appertaining shall remain as heretofore in my possession  
 during my natural life Provided further That should  
 there be heirs of my natural body such heirs shall have and  
 hold the same And provided further That should there be  
 natural heirs and such heirs should cease to exist the above  
 named premises shall be held as above named.

 the Georgia Construction and Investment Company has or  
 had in the following described tract of land. Beginning at a  
 corner of Chesley Gowens lot at a stake on the north side of Broad
