during the term of my natural life and for the further consideration of Five Dollars to me in hand well and truly paid by the said E H Bovee at and before the sealing of these presents the receipt whereof is hereby acknowledged I have granted bargained and sold and do hereby grant bargain and sell and release unto the said E H Bovee that lot or parcel of land situate lying and being in the State and County aforesaid just in the suburbs of the City of Greenville and known and designated as Lot No 6 on plat as surveyed by W A Hudson Esq Nov 1st 1871 commencing at a station corner of Marion Brown's lot and street and running down the line of said lot one hundred and fifteen feet to corner of lot 8 thence along said lot three hundred (300) and thirty feet to corner on street thence along said street one hundred and (115) fifteen feet to street in rear of Mrs Seuggs thence along said street three hundred (300) and thirty feet to the beginning containing one acre more or less and being the lot conveyed to me by Henry Woodward on the 10th day of August 1848 and conveyed to said Woodward by Samuel Stradley the 5th day of January 1870.
