One hundred and seventeen (117) ft. to a stake on north East corner lot No. 1 of Smith; thence with said lot N. 40 E. One hundred and thirty two (32) ft. to a stake at corner of Smith's lot, thence with the course of said lot N. 40 E. to a stake at corner of said lot and Glenwell Street with Green St. in 22 new fms hundred and twenty five ft. to a stake at corner of said Glenwell Street with Green St. S. 74 E.
