title and interest in and to all that certain piece or parcel of land situate lying and being in Greenville County, State of South Carolina, about one mile south of Belton post office, and having the following metes and bounds to wit: Beginning at a white oak north of the dwelling, thence nearly a south course to a pine thence west of south to a Post Oak bush, thence to a Hickory on land of Estate of H. E. Lynch, thence to a stake on Spring Branch, thence down said Branch to a white Oak dead and down corner of land of F. P. Newby, thence with said Newby's line to a dog wood thence across the to a black oak sapling, thence to a poplar, thence to a Hickory Bush, thence to the beginning corner containing (according to the deed of Wm.
