McDough of the same County in the (the receipt whereof is hereby acknowledged) have granted, bargained, sold, and released, and by these Presents, DO GRANT, bargain, sell and release unto the said Jabez A. McDough all that piece or parcel

and tract of land containing Thirty five or less acres or less situate lying and being in the County and State aforesaid about six miles from Greenville South Carolina on the west side of the Saluda River and Greenville Rail Road, and having the following metes and bounds to wit: Beginning at a stake iron on east side of road leading from Greenville City to Piedmont and running thence north 41.50 to a Red Oak from gone stone 3.00 on the old Blasingame line thence with mid line S 4 E 8.20 to a stone 3.00 on thence S 80 3/4 E 4.20 to a stone 3.00 on a cross said Rail Road. Thence N 12 1/2 W 8.80 to the beginning corner adjoining lands of J. J. Mackey and J. A. McDough and being the northern part of the parcel tract of two hundred acres conveyed to me by John L. Ancker which was a part of Four hundred acres known as the Woodville place as per survey made by John Watson D.S. April 11th 1834.
