of Section 34, running at a stone 34 1/2 links east of a Spanish
marker in the corner. Thence N 64° 20' 15.48 to a stone in the center
of 34 to a stone in the S 74° E 15.90 to a stone in the center of 34 to

the same more or less, bounded by J. H. Shockey,
Wm. Miller, D. D. Wren, J. H. Shockey, Methodist Church & others.
