(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

(M. J. Reid) all of that five acre or more of land, situate lying and being in that State of South Carolina, near branch waters of Middle Upper river, having the following lines, meters and bounds to wit: Beginning at a stake on the road leading from Liberty Church by M. J. Reid, running thence with said road N. 60° W. to a stake on said road, thence N. 60° W. E. 700 ft. a stake, thence N. 78° W. 117 ft. to a stake, thence S. 53° W. to the beginning corner, containing several acres more or less bounded by lands of M. J. Reid and A. B. Reid and

Heirs and Assigns, against *us* and *our* Heirs, and every person whomsoever, lawfully claiming, or to claim the same, or any part thereof.
