(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said *Young Moseley* that certain piece of land situated

of his said land lying *on the corner of Pearl Creek and Shady in the State of South Carolina being part of the tract of land known as the Banisterland sold, to P. J. Donthit the 1st day of January 1875, Beginning in the corner of Long Branch road running therefrom N 17° 15' E 25' to a stone 38 rods, thence N 58° E 17' 10" from 38 rods, thence N 27° 24' 45.80 to a stone 38 rods, thence S 78° 14' 00" to Long Branch, thence down said branch to a water oak 38 rods, thence beginning corners containing 56 fifty six acres more or less, Being Lot # 10, also one other lot lying east of the S. Moseley Estate added to P. J. Donthit's land on the 1st day of February 1886 to J. Donthit Master and then sold to Rosa E. Dickson on the 1st day of March 1895 by D. P. Barnes Moseley, containing twenty seven more or less, being part of the above lot. Formerly the Banister land, being the land # 14 & 5 of the P. J. Donthit land sold on the first day of July 1886 by P. J. Donthit B&B/612*
