deceased, beginning at a stone on W. P. Bates' line, thence with said line to
a creek on the road leading to Tyger Church, thence with said road to
the Warren Davis line, thence with said line to Maneria Glennings line;
thence with said line to Burwell Stewarts line, thence with said line to the
beginning corner. Containing forty (40) acres more or less.
