(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said G. W. Poole, all that piece parcel or tract of land situate lying and being in being in the County and State aforesaid and on the North side of Enoree River, Beginning on a Stone (Williams corner) thence S 73 E 9.10 ch to a Stone, thence S. 18 E. 44.73 ch to Enoree River, thence up and with the meanderings of said River 10.50 ch to the mouth of a ditch, thence N. 6 E. 1.60 ch to a Stake thence N 17 E 42.19 ch to the Beginning corner, containing forty (40) five acres more or less, adjoining lands of the D. R. Poole Estate James Rol. G. W. Williams, and others

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said Premises before mentioned unto the said G. W. Poole and his Heirs and Assigns forever.

And I do hereby bind myself and my Heirs, Executors and Administrators, to warrant and forever defend all and singular the said premises unto the said G. W. Poole and his

Heirs and Assigns, against me and my any other person or persons Heirs, and every person whomsoever, lawfully claiming, or to claim the same, or any part thereof.
