acres more or less and bounded by the lands of Earl M. Kitchens, James C. Lewis, John
Griffy, Mary Jane Hill, and has the following lines and bounds. Beginning at a stone
(37 1/8 acres) on the east side of the road running thence N. 89° 15' E. 11 fms.
with road to stake thence N. 71° 31' E. 20.10 chs with said road to stake; thence N. 68° E.
