thence forward the west of said residence and run a southwest course 194 yards
to line between said E. C. Gilreath & A. T. S. Dill, thence along said line 45 yards
to where the said road makes a turn in A. T. S. Dill's land, leaving said line,
and turning said line again, running a northwest course 30 yards to a
cross branch running from W. H. Dill's Powder Farm, thence from said branch
a south west course 80 yards to A. T. S. Dill's & W. H. Dill's Powder line, said road is
now & will remain twenty feet wide. Every place it runs through may
