release unto the said John & wife Masters, all that tract or parcel of land
situate, lying and being in the State of South Carolina above named
on the waters of Saluda River and Galloway Creek
being a part of the property of the said John & Rebecca Masters, beginning at a Boxelder tree near a large
hollow branch on the east side of which is known as Rock Branch and runs
N 54 E 32 50, with the old fence line to a slate at what is known as Daniel's
Branch, thence up and with said branch to a Walker corner, a post
Oak about distance above the head of the branch at the head of the
hollow, thence N 26 E 13 50 to a Spruce Pine on the west side of Galloway Creek, thence
east 1 chain to a stake in the old fence line, thence with the old fence line N 28 W
16 50 to a Maple old Walker corner on east side of Galloway Creek, thence S 75 W 31 50
to a Hickory on a ridge, thence N 75 E 16 to top of Rocky Ridge at a station of Floyd Masters
line, thence S 14 W with Floyd Masters line 25 chains to a steel post 3 m from Floyd Masters corner,
thence south and down the meanders of the branch to a water oak 10 m from corner, thence N 50 E
