Logan all that certain piece parcel and tract or lot of land situated, lying and being in the County of Greenville and State aforesaid on branch waters of Reedy River and known as lots No. 21 and 22 in W.A. Hudson's Survey for O. C. Dickson and known as part of the Dickson Annex. beginning on a stone st. on the street that runs South of the old Charles D. Hammond house place, and running thence S 66 W 9.75 to a stone x 2 ft South end corner, thence S 36 1/2 E 2.45 to bend in street, thence S 31 E 6.50 to bend in street to stone st. thence N 26 E 12.75 to street above referred to, thence with the street N 66 W 8.45 to the beginning corner.
