(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ansel Arnold, all that piece of land containing one half of an acre, more or less, situated, lying and being in Greenville County, in the State aforesaid, about three and one half miles west of Greenville Court House, near the Southern Railway on the South side thereof, having the following measurement and bearings, viz.: Beginning at a stone 37 c.m. and running the same due west 148 feet to a iron pin 24 c.m. thence N 13 3/4 W 145 feet to a iron pin 21 m.m. thence N 89 10' E 139 feet to an iron pin 34 m.m. thence S 13 3/4 E 161 feet to the beginning. Bounded north by a lot of the Farmers Aid Society, west by J. D. Cott's lot; on the south by Ansel Arnold's lot, and east by W. H. C. A. Franklin's lot and being part of lot No. in a plat made by W. D. Howell of said Franklin's land. And more particularly described by a plat hereunto attached.
