Markley,* all that parcel piece and lot of land situate, lying and being in the City of Greenville, County & State aforesaid having the following metes & bounds, commencing at a corner stake on Boyce St., eleven feet from center of C N & W R R Street - and running thence N 6° 30' E 43 1/2 feet along Boyce St. to Hudson Alley; thence N 40° 3' W 105 1/2 feet along line of Hudson Alley to wards line; thence with wards line S 19° 38' W 95 1/2 feet to stroke eleven feet from center of C N & W R R Street; thence 120 ft with curve of said street to beginning corner containing 150 88 sq. feet and being part of lot deeded to Thos G Glenn by Mrs S. A. Preacher on November 8th 1889 and recorded in Book D Pg 265 in office of R M & Greenville County.
