successors in office forever, the following described Real Estate, to wit: - All that piece of land or a part of land situate, lying and being in the fourth Ward of the City of Greenville and being a continuation of Highways Street from Cleveland Street till it intersects with Webster Street, Beginning at an iron pine 3x on the Cleveland and McBee old line, and running thence \$81 & 10.45 Pcs to an iron pine 3x, thence 21.25 ft E 10.0 rods to an iron pine 3x on Webster Street, thence 21 3/4 W along said street 92 links to an iron pine 3x, thence 8 1/4 W 10.0 rods to an iron pine 3x, thence 21.81 R 1/2 10.00 to an iron pine 3x on the Cleveland and McBee line, thence with said line \$4 & 82 links to the beginning, containing One and 5/100 acres, more or less,
