all that certain piece parcel or lot of land situate lying and being in the Town of Greenville, County of Greenville and State aforesaid on the South side of the Airline Rail Road, Beginning at a stone 37 and running with right of way of said Rail road N 72 1/2 E 62 feet to a stone 39, thence S 6 1/2 E Three hundred and sixty nine and one half feet to a stone 31 on street, thence N 56 1/4 W Seventy six and one half feet, thence N 6 1/2 W Three hundred and five feet to the beginning, Containing One half City acre, more or less,

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said Premises before mentioned unto the said J. D. Mayfield, his Heirs and Assigns forever.

And I do hereby bind myself, my Heirs, Executors and Administrators, to warrant and forever defend all and singular the said premises unto the said J. D. Mayfield, his Heirs, and every person whomsoever, lawfully claiming, or to claim the same, or any part thereof.
