(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and
release unto the said Robert A. McDavid, his heirs and assigns forever, all that
piece, parcel or lot of land, situate, lying and being in the City of Greenville
County and State aforesaid, and bounded and bounded as follows, to wit; beginning
on an iron pin on Washington Street 50 feet from the N.E. corner of Richardson
Street, and runs S 20 E 70 feet to an iron pin, thence S 70 E 60 feet to an iron pin on
Gowers line, thence N 20 E with Gowers line 70 feet, to an iron pin on Washington
Street, thence N 70 W 50 feet with Washington Street to the beginning corner,
Also all that other piece parcel or lot of land situate, lying and being
in the City and County of Greenville, and State aforesaid, beginning at an
iron pin on Richardson Street 90 feet from Washington Street, and runs
thence S 20 E 60 feet with Richardson Street to an iron pin, thence S 70 E
