(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. W. Crookshanks, all that piece parcel and lot of land situate lying being in ward 11 of the City of Greenville, and in the County and State aforesaid, fronting on Glover St, and bounded on the south by an alley, and adjoining lots of David Richardson and R. C. Davis, and having the following metes and bounds: beginning at a stake corner of said Glover St, and alley, thence with the said alley S 74 N 1/2 E 100 chains to a stake on said alley, thence N 1/2 W 50 feet to a stake, thence N 44 1/2 E 100 feet to the beginning corner, and containing 5000 sq ft more or less, said parcel or lot of land is the same that was by J. C. Gower to Mary Ann Garrison conveyed on 12th day of July A.D. 1884, by general warranty deed, recorded in Vol. 107, p. 512 and by the said Mary Ann Garrison to W. H. Irvine conveyed by deed dated January 1891, and duly recorded in R. M. C. office in Vol. 74, p. 611, and by said W. H. Irvine to me conveyed by deed dated July 7, 1893, and duly recorded in Register's office in Vol. A. C. A. at page 60.

TO HAVE AND TO HOLD, all and singular the said Premises before mentioned unto the said J. W. Crookshanks and his Heirs and Assigns forever.

And I do hereby bind myself and my Heirs, Executors and Administrators, to warrant and forever defend all and singular the said premises unto the said J. W. Crookshanks and his

Heirs and Assigns, against me and my Heirs, and every person whomsoever, lawfully claiming, or to claim the same, or any part thereof.
