release unto the said Theo Croft-Owens, all that piece of land aforesaid  
land, situate, lying and being within the incorporate limits  
of the City of Greenville, in the State and County aforesaid  
and described as follows: Beginning at a point (11' 8")  
Ninety one and eight inches from the corner of Main and North  
Street, running (16' 10") sixteen feet and ten inches down Main  
Street, thence (70') Seventy feet towards Brown Street, thence  
(16' 10") Sixteen feet and ten inches towards North Street;  
thence (70') Seventy feet to Main Street to point of beginning,  
being a portion of the lot conveyed by John C.  
Brooks, to the said Nicy Ann Wright, on 19th day  
of January 1881.

anywise incident or appertaining.
