Muchlerath, Trustees of St. Matthew Stockaid Society, a certain lot or parcel of land lying and being in Greenville County and State of South Carolina, situated near the Wetherford Road, about six one half miles from Greenville Court House, beginning at a stone near the St. Matthew W & Church, thence S 61 3/4 W 3.50 chs to an old Bone near a Hickory, thence N 9 3/4 W 1.50 chs to an Oak Stake, thence N 80 1/2 E 3.36 chs to the beginning corner, containing one fourth of an acre, more or less.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said Premises before mentioned unto the said Trustees of St. Matthew Stockaid Society their Heirs and Assigns forever.

Heirs and Assigns, against me and my Heirs, and every person whomsoever, lawfully claiming, or to claim the same, or any part thereof.
