land situate in the State and County aforesaid about $\frac{1}{4}$ miles SW of the City of Greenville & Co. containing Twenty-eight (28) acres more or less, and hath such marks bounds &c. as follows viz: Beginning on a stone 340 m. on Road thence S $75^{\circ}E$ 34.00 to a stake 340 m. on the Creek, called Brush Creek, thence up meanders thereof to a stake, thence a straight line to a bend in Road thence S $69^{\circ}W$ 3.50 to a bend, thence S $15^{\circ}W$ 3.50 to a bend, thence S $74^{\circ}W$ 8.00 to a bend thence S $60^{\circ}W$ 7.50 to the beginning former bounded by lands of Mrs. H.
