situate lying and being in ward 11 of the city of Greenville in the county and State aforesaid, fronting on Glover Street, and bounded on the south by an Alley, and adjoining lots of David Richardson and A. G. Davis, and having the following metes and bounds; beginning at a state corner of said Glover St. and Alley, thence with the said Alley S 44 1/2 W 1.60 chains to a state on said Alley; thence N 2 1/4 W fifty (5) feet to a state; thence N 7 1/4 E 1.60 chains to a state on said Glover St. thence along with the said Street S 2 1/4 E fifty (5) feet to the beginning corner and containing 5000 sq feet, more or less.
