Pitman*, all that piece of land or tract of land lying and being situate in Greenville County, Sulphur Township in the State aforesaid on Meadow Fork of Marsh Creek, waters of South Tyger River and is known as part of the William Tilley tract and lying preparatory bare in said land and commencing on a Chestnut Oak 34, which is also the corner of A 1/4 Southwrose Land and is also one corner of the William Southern land, and runs thereby with Milton Hammells land and line to the corner, thence with William Gorrells land line and corners until it comes to Robert Pitman the corner on a white oak now down on a rock shoal on a small branch, and then runs down said branch to a rock 34, at the mouth of said branch on the south side of Meadow Fork Creek, and runs up said creek to a rock 34, also the corner of William Tilley Jun land, and thence with the said William Tilley land a straight line to the beginning Chestnut Oak corner,
