release unto the said J. Hollins Howard, all that tract of land situate lying  
and being in the head waters of Morgan Creek in Greenville County, Branch  
waters of Saluda River; Beginning on a rock being William Gassells  
corner, running thence a straight line Eastward to a Post Oak 34 on the  
main road above Joberry Thompsons running thence North East with  
said post to a rock 34 and thence Jasper Ballards corner 34, running  
thence Eastward with Joseph Ballards line to a Black Gum 34 running  
thence with said Ballards line to a rock 34 on the branch road  
Ballards line, thence west with the meanderings of said branch to  
a white oak 34 B & Chastains corner 34, thence west with the meander-  
ings of branch to a rock 34 at the old ford, said B & Chastains corner  
thence west a straight line to a Chestnut 34, it being the said B &  
Chastains and Robert Reetons corner, thence Southward with  
Robert Reetons line to a Black Oak 34, William Gassells corner  
thence Southward with said Gassells line to the beginning
