(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and  
release unto the said Thomas W Austin, all my interest right and claim of  
every kind whatsoever, including my right and claim of Dower in all  
3 pieces parcels and tracts of land situated lying and being in the  
County and State aforesaid and being the same 3 tracts of land  
conveyed by my husband Vincent Austin to the said Thomas W  
Austin by deed bearing date the 1st day of August 1887, & recorded  
in Book N. 13, at page 176, in the office of the R. M. C. for said County,  
bounded by lands of Nimrod Donaldson, Jno. C. Gullins, estate,  
Frank Austin & others, known as Vincent Austin's Home place,  
Containing two hundred and eight acres, more or less.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in any-  
wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said  
Thomas W Austin and his Heirs and Assigns forever.

And I do hereby bind quit claim against me myself Heirs, Executors and Administrators to warrant and forever  
defend all and singular the said premises unto the said Thomas W Austin and his

Heirs and Assigns, against me and my Heirs, and every person whomsoever lawfully  
claiming or to claim the same or any part thereof.
