in the State aforesaid for and of Twelve Hundred and fifty Dollars to me in hand paid at and before the sealing of these presents by William Plumley of Greenville County in the State aforesaid (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William Plumley a certain tract or parcel of land lying and being situate in the County of Greenville, in the State aforesaid on both sides of South Carolina River, and is part of the tract of land conveyed to Stephen Shammell, by Deed by J. Ward the 26th day of August A.D. 1809, and by Stephen Shammell to me April 9th 1885, and known as the Jackson Island tract, and runs as follows: Beginning on a Chestnut and a Hickory 34 Berryman Gamells Corner, thence N 67 1/2 E 12.75 Chains, to a stone 34 in place of White Oak 34, thence N 53 1/2 W 7.70 Chains to a stone 34, thence S 24 W 10.25 Chains to stone 34 above Spring, thence N 26 W 7.60 Chs to a stone 34, in place of Hickory, thence N 25 W 5 7.80 Chains to a stone 34 near spring and in place of Maple, Red Oak 34, S 23 3/4 E 13.10 Chains to a stone 34, thence S 47 1/2 W 3.05 E to stone 34 in place of Red Oak, thence N 87 3/4 W 17.80 Chs to a stone 34, in place of Chestnut Oak, thence N 41 1/2 W 11.15 Chs to a stone 34, S 78 W 11.70 Chs to a stone 34, Hickory down, thence S 12 E 15.75 Chains to a stone 34, near top of high rock, thence S 6 W 15.00 Chains to a stone 34 in place of poplar and near wind trees, near a branch, thence S 79 1/2 W 9.85 Chains to a stone 34 Wm Gamells Corner, thence S 12 E 17.75 Chains, crossing South Carolina River to a stone 34, in place of Hickory near a Junco Corner, thence S 80 E 20.20 Chains to a Junco 34, thence S 78 E 26.44 Chains to a Hickory 34, thence S 49 E 3.63 Chs to a stone 34 on James Gamells line, thence N 30 E 12.82 Chains to a stone 34, thence S 68 E 47.85 Chains to a stone 34 by White Oak stump, thence N 1 3/4 W 20.00 Chains to the Beginning, containing five hundred and thirty (530) Acres more or less bounded by lands of James Gamell, Berryman Gamell, Malin Belue, Whitman Plumley, Wm Gosnell and William Root.

And I do hereby bind myself my Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said William Plumley His Heirs and Assigns, against me and my Heirs, and every person whomsoever lawfully claiming or to claim the same or any part thereof.
