(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and

release unto the said H. A. Griffith, R. E. Cox, A. R. Smith Jr., W. S. Baldwin and G. N. Blakely,

themselves and assigns forever, all that piece of land situate, lying and being in Austin Township in the County and State aforesaid, containing fifty-five one hundredths $\frac{1}{2}$ of an acre, more or less, Beginning on a stone on line between land of Poplar Springs Church and other lands of mine, thence N 10° 45' E 244 L to stone on Factory road, thence S 70° W along said road to stone 1778 L, thence along said road S 53 1/2 W S 91 L to stone on Robertson and Poplar Springs Church line, thence S 89 E 33 1/2 L to beginning former, in trust nevertheless to you and upon the following uses, purposes and trusts, that is to say, to permit the persons purposing and the members thereof the Mauldin Guards and the Poplar Springs School, being unincorporated associations, to erect a building thereon, and to use the same for the purposes of said associations; that is to say, the said Mauldin Guards to use and occupy the upper story of said building as a drill hall or for any other purpose in keeping with the object of said association and the said Poplar Springs School to use the lower floors for school purposes. The said trustees or their successors in office are hereby empowered to sell and convey the said premises to such persons or persons, and upon such terms as may be directed by said associations and at their request, the same to be indicated by a majority vote of each certified to by their respective secretaries and countersigned by the respective Presidents or other Presiding officers, I further grant to the above mentioned trustees for the said named association the right to name my spring, the same being known as the Poplar Spring, the said use to the water we have forever.

Heirs and Assigns, against me and my Heirs, and every person whomsoever lawfully claiming or to claim the same or any part thereof.
