Jones Mill, containing one acre more or less, and the right of way for a public road running through it, beginning on a slope on the edge of said right of way near the south west end of the bridge, running thence N 34 1/4 W 3.5 rods, to a white Oak tree near the pond, thence S 63 1/2 E 3.17 rods, to a stone 14 in. thence S 34 1/4 E 3.5 rods, to a slope on m. thence N 33 1/4 E 3.17 rods to the beginning corner, bounded by lands of the said G. R. Nesbitt and Spartan L. Jones,

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in any wise incident or appertaining.
