Drivine*, all that lot of land situated in West End, City of Greenville State & County aforesaid and having the following metes & bounds, viz: beginning at an iron stake corner of Frank Craig's lot and running with said Frank Craig's line N 47° 8' 2 chains to an iron stake corner of Robert Scott's lot, thence with said Robert Scott's line S 67° 8' 2 1/2 chains to a stake, thence S 22° 10' 2 chains to a stake, thence N 47° 8' 2 1/2 chains to the beginning corner, containing one fourth of an acre, more or less. This is the same lot that was formerly surveyed by Geo W. Brown by deed dated Sept 5th 1894, and to said Brown surveyed by James Poole by deed dated Sept 24th 1894, and recorded in R. M.
