and before the sealing of these presents by D J Moon (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said D J Moon all that certain piece or lot of land in the County

of Greenville, State aforesaid, containing fully acres, more or less, having the following metes and bounds; Beginning at a stake on Beaverdam Creek at corner of land of W Bridwell, thence S 2 1/2 W 5.13 to poplar 34 m, thence S 4 E 29.58 to pine stake 34 m, thence along line of land conveyed by me to W Bridwell, N 80 1/2 E 13.50 to stone 34 m, thence N 74 W 20.00 to stake 34 m, on Beaverdam Creek thence up the meanders of said Creek to beginning corner on said Creek at the mouth of a spring branch bounded by lands of W Bridwell, myself, and Beaverdam Creek being a part of the place formerly known as Mrs G Turner's Home Place, and being in accordance with survey of D M Hunt of date Nov 17th 1875, and being a part of the land conveyed to me on Nov 26th 1875, by W D Turner master,
