and before the sealing of these presents by **Julia M Gilbreath** (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said **Julia M Gilbreath**, all my undivided one half interest in the following lands, all that tract of land containing two hundred and fifty eight acres, more or less, situate in the County of State aforesaid and on Grover Creek adjoining lands of G E McKinney's estate, B D Garrison, Mrs Charles and others, and fully described in a plat made by W A Anderson November 4th 1868, also all that other tract containing forty eight acres, more or less, adjoining lands of J H Jenkins, Rhodes and others. Also all that tract of land situate in the same County and State containing three hundred acres, more or less, being part of the tract known as the Laurens Brook tract adjoining lands of J H Jenkins, Mrs Mary Cleveland and others. Also all those tracts described in a deed dated July 24th 1880, and recorded in the R. M. C office in Book N. S. page 615, as tracts 1, and 3, containing in the aggregate three hundred and eighty four acres, more or less, all the above described four parcels of land containing in the aggregate nine hundred and ninety (990) acres, more or less, in all of which I hold an undivided one half interest, and in which S P Burbridge holds the other half interest and embracing all the lands which the said S P Burbridge and I own jointly in said County & State in Grover and Garret Townships.
