Road. It is part of a tract marked Lot No 1 in the survey and
division of a tract of land known as the John Hammell
Place, sold to S. C. Dickson by J. H. Hammell and sold
to me by the said S. C. Dickson. It is bounded by lands of
R. D. Shands, S. C. Strand and S. C. Dickson, and contains
Seven and Three fourths acres. Of which be the same more or less,
and runs as follows: Beginning on a white oak corner
of S. C. Shands and running thence S 79 34' E 9,000 chains to a
tree in the Rutherford road, thence along said Road 18,75
chains to a stone 3x3 m. thence N 79 34' W 225 chains to a
