right of legal descent lying and being in the County and
State aforesaid in the State of South Carolina, it being a divided
one half interest in the tract of land formerly known as
the *Wade* place, and recently owned by the said *John Wade* and
two said *Thomas* and the said *John Wade* in joint
and *John* died in the year 1798. The *Community*
was *B. F. Foster* & *J. W. Taylor* at the request of the
