KNOW ALL MEN BY THESE PRESENTS, That

I Henry M. Shumate

in the State aforesaid for and in consideration of the sum of Nine thousand five hundred Dollars to me in hand paid at and before the sealing of these presents by C. D. Stradley & Geo. T. Barr partners as Stradley & Barr (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. D. Stradley & Geo. T. Barr partners as Stradley & Barr all of that certain piece of land or lot of land situate lying & being in the City of Greenville in the State aforesaid on the west side of Main Street in Ward three of said City and bounded on the East by Main Street or South by lot of said Shumate, an alley of ten feet running the entire length of the said West boundary between the lot herein conveyed and the said lot of Shumate being heretofore granted on the North by lot of W. L. Mauldin and has the following Courses and distances to wit? Beginning at the corner of W. L. Mauldin lot on Main Street and in the Center of the brick division wall and running thence with the inside of said wall and with Mauldin's line one hundred & twenty feet Thence at right angle with said Mauldin's line Forty six feet four inches to the line of Shumate lot, same now occupied by Stradley & Barr known as Central hotel building, and to center of division wall thence at right angle one hundred & twenty feet along the line of said Shumate's lot, Central hotel building to Main Street, thence with Main Street Forty six feet four inches to the beginning corner. This lot includes one half of the brick wall on Shumate's side and also one half of the brick wall on Mauldin's side. Said property is part conveyed to the water town steam engine Company by J. D. Donisthorpe Aug 14, 1884, and by the city warehouse company & fire 10, 1885, also the right of entering through said Shumate property from Laurens Street for the purpose of hauling and getting into and out of the alley way hereinbefore provided for, and also the right to carry water from the top of the building and sewerage to the said Laurens Street.

Barr partners as Stradley & Barr their Heirs and Assigns, against me and my Heirs, and every person whomsoever lawfully claiming or to claim the same or any part thereof.
