stone corner, Wilson's land, and going in a line of a M. C. Melvin  
to a wooden stake; thence straight to the center of the Jordan road  
to a stone; thence with the said road to opposite the rock corner  
at the beginning corner; thence to the beginning corner, Con-  
tinuing one line west, being a part of a tract of land  
deeded to me by D. L. Stiles Oct 20, 1890.
