 and before the sealing of these presents by Stephen King of said City  
 (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and  
 release unto the said Stephen King All that lot or piece of land situated in the  
 City and County of Greenville, State of South Carolina, on the north side of High  
 Land Avenue, formerly known as West Street having the following  
 greater and lesser dimensions: Beginning at a stake .3x on the north side of said  
 Highland Avenue One hundred and eighty nine (189) ft. west of the  
 eastern line of Mulberry street running thence N. 56 E. Two hun-  
 dred (200) ft. thence N. 34 W. Sixty (60) ft. thence S. 56 W. Two hundred  
 and (200) ft. to the North line of Highland Avenue; thence along  
 said street S. 8x E. Sixty (60) ft. to the beginning corner containing  
 27 1/2 of an acre, more or less, being the same lot conveyed to me Mar.  
 1890 by Stephen King, the deed for which is recorded in R. H. C.  
 Off. 1890 in Land Cases, in Bk. I. Vol. 636.

I bind myself and part of the consideration of this deed, the granted herein  
 to possess, and do now warrant and the payment of a certain  
 bond and mortgage executed by me to Interstate Building and  
 Loan Co. of Atlanta, Ga., in the sum of one thousand dollars.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in any-  
 wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said Stephen King  
 his Heirs and Assigns forever.

And I do hereby bind myself to  
 defend all and singular the said premises unto the said

Heirs and Assigns, against all and every person whomsoever lawfully  
 claiming or to claim the same or any part thereof.

Heirs, Executors and Administrators to warrant and forever
