Brier, Thos. Bower and a street running by John Leonard

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in any wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said Katy Holley Her heirs and Assigns forever.
