and bounds, beginning on an Iron Pin in the edge of the road leading  
from Taylors Sta to Brushy Creek Church, thence S 74 1/4 W 4.90 chs. to any  
Iron Pin thence N 10 1/4 W 4.43 chs to any Iron Pin on the Right of Way of  
said Southern Railway, thence S 77 1/4 W 3.80 chs. thence S 10 1/4 E  
6.45 chs to an Iron Pin, thence S 77 1/4 W 4.00 chs to an Iron Pin thence  
S 5 N 18.13 chs to a stone, thence S 86 3/4 E 1.32 chs to a new Road, thence  
along said road as the line 25.50 chs to the beginning corner
