and before the sealing of these presents by G H Neves and J P Shockley, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said G H Neves and J P Shockley, a certain tract of land situate lying and being in said State and County near the City of Greenville on the Public road leading from Greenville to Chick Springs, having the following miles and bounds viz: Beginning on a stone in the edge of said Public road, thence N 17° E 15.50 chs to a stone 34, thence N 72° 40' W 5.00 chs, to a stone 34, yr, in the bottom of a branch, thence up the meander of said branch 3 chs, to a stone 34 in the bottom of said branch thence S 20° E 5.45 chs to a stone, thence S 17° 40' W 5.30 chs to a stone on the edge of said Public road, thence along said road at the line S 86° E 4.07 chs to the beginning corner, containing four and eighteen one-hundredths acres, more or less, bounded by lands of Jas Wood, Brockman and the said J J Willis and others.
