in the Sixth Ward of the City of Greenville, in the County and State aforesaid, containing one half of an acre, more or less, being the lot surveyed to me by J T Littlejohn by deed dated August 28th 1894, and recorded in the R M to office for said County in Book 666 Page 677, with following lines: Beginning at branch at the point of Mrs Alice Verguesons line next Grantors house place, thence along line of Purman University lot to Street or University grounds one hundred feet more or less, thence with said Street or Grounds two hundred and twenty four feet more or less, to John Collins corner, thence with Collins line one hundred and five feet to middle of branch, thence with middle of branch about seventy feet to Mrs A C Verguesons line, thence with her line in paid branch to the beginning.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said G A Norwood His Heirs and Assigns forever.

And I do hereby bind myself and my Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said G A Norwood His Heirs and Assigns, against me and my Heirs, and every person whomsoever lawfully claiming or to claim the same or any part thereof.
