lying and being in the State and County aforesaid on the right bank of North Saluda River, and runs as follows: to wit: Beginning at a stake on said River, thence S 85 1/2 W 11.50 ch to a ditch, thence down said ditch S 18 E 1.18 ch to a creek in ditch thence down ditch S 9 E 3.32 ch to a stake in ditch, thence S 88 1/2 W 17.00 ch to a branch at road, thence up said branch 5.00 ch to a stake, thence west S 48 E ch to a spring, thence N 74 W 4.00 ch to a stone, thence S 85 1/2 W 34.50 ch to a stone, thence S 15 W 9.65 ch to a stone, (corner of B.
