Know all men by these presents, that we, Mary Boswell, J. S. Boswell, B. E. Boswell, B. P. Boswell, Landrum Boswell,annie Hines, A. C. Boswell, Eugenie Trammell, and Carrie Childs, in the state aforesaid, for, and in consideration of the sum of One hundred and fourteen (\$114) dollars, to us in hand paid sat and before the sealing of these presents by Nancy Trammell, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said, Nancy Trammell, all that piece, parcel or tract of land, situate, lying, being in the State of South Carolina, Greenville County, about 16 miles from the city of Greenville S.C., in Saluda Township, on water of Musch Creek, it being lot No. 8, in the division of the Real Estate, of Benjamin Boswell, (deceased), containing 21 acres, more or less, bounded by lands of R. T. Moore, lot No. 7 and others, and runs as follows, Viz:- Beginning at a stone on Mrs. Mary Boswells land, and runs thence S. 5 1/2 W 22.50 chs. to a stone 3 x m m thence S 10^o 1.20 chs. to a stone on McInnis's line, 3 x m m thence N 88 1/4 E 15.80 chs. to a stone 3 x m m thence S. 7.8 E 300 chs. to an ash tree. 3 x m m on branch thence N 27 E 11.50 to a stone 3 x m m thence N 3.6 W 900 chs. to the beginning corner.
