 (the receipt whereof is hereby acknowledged), have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and
 release unto the said Thomas L. Swinton all my undivided one half interest in
 all that piece of land and tract of land situate lying and being in the County
 of Greenville and State aforesaid on Pine Mountain in Chick Spring Township
 Containing twenty nine and one half acres, more or less, and having the following
 metes and bounds and courses and distances, to wit: Beginning at a black
 gum tree, and running thence S 81 1/2 E 87.20 to a stone 340, then N 58 1/4 E 8.85 to a
 black gum 340, then E 62 E 8.15 to a hickory 340, then N 80 W 8.70 to a stone 340,
 thence N 13 W 4.14 to a stone 340, then N 20 W 4.40 to a stone 340, thence N 30 N E 7.20
 thence N 57 W 4.50 to a red oak 340 and thence S 85 W 81.50 to the place of the beginning,
