KNOW ALL MEN BY THESE PRESENTS: That I Mary C. Miller, of Travelers Rest, Greenville County, State of South Carolina, being the legal holder as mortgagee, of a mortgage in fee simple bearing date---day of---1895 of a certain tract of land lying being, and situated in O'Neal Township, County of Greenville, and State aforesaid, containing one-third of an acre, more or less, having metes and bounds as follows: Beginning on poplar tree near N. E. corner of distillery building, and running thence W. 32 feet to a stake; thence S. 20 feet to a stake; thence W. 90 feet to a pine tree; thence S.
