State of South Carolina RENUNCIATION OF DOWER.
County of Greenwood.

Whereas heretofore a certain deed was executed and delivered by Andrew Miller and Wm.H. Frazier to W.L. Trenholm, Trustee of Alexander Macbeth and E.F. Trenholm, now Macbeth, his wife, under a deed of marriage settlement dated Feb. 4th. 1868 and conveying to said W.H. Trenholm, Trustee as aforesaid, a certain tract of land in the County of Greenville and State aforesaid on the Buncosbe Road about four miles above the City of Greenville, containing two hundred and fifty acres, more or less, which deed bears date Jan. 1, 1876, and is recorded in office of Register of Mesne Conveyances for Greenville County, in Deed Book H.H. at page 207; and whereas Mrs. E.M. Frazier, the wife of said Wm.H. Frazier, executed upon said deed a relinquishment of her right and claim of dower in and to the said land, which relinquishment was defective in that the Trial Justice who took said relinquishment failed to affix a seal to his certificate; and whereas a portion of said land has since been conveyed to various parties, and is now vested in Fannie P. Beattie, Perry Beattie, and Emilie E. Beattie, by virtue of a deed bearing date Oct. 3, 1896, and recorded in said office in Deed Book Z.Z. at page 861; and the remainder of said tract of land has been conveyed to and is now vested in William F. Thackston by virtue of a deed bearing date April 3, 1896, and recorded in said office in Deed Book V.V. at page 682; and whereas it is described to clear the title of said tract of land by supplying the defect in said attempted renunciation of dower:

Beattie and Perry Beattie, of the City of Greenville, in the State aforesaid, for and in consideration of the sum of Twenty-seven hundred and fifty-four 75/100 Dollars, to us in hand paid at and before the sealing of these presents by The Union Bleaching and Finishing Company, a corporation, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said The Union Bleaching and Finishing Company, a corporation as aforesaid, all that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina and County of Greenville, about three miles north-west of Greenville Court House, having the following notes and bounds, according to a plat thereof prepared by W.H. McCollough, Civil Engineer, bearing date the 16th. day of September, 1902, and herewith delivered, to wit: (Beginning at a point on the south west side of the Buncosbe Road, corner of W.F. Thackston land, and running thence with said W.F. Thackston's line S. 28° W. twenty-six hundred and fifty-three (2653) feet to a corner on Reedy River; thence down said river, following the meanders thereof, to corner of Minnie L. Hillhouse's land; thence along said Minnie L.
