Sudduth, his heirs and assigns, all of my right, title and interest, (being an undivided one-half), of, in or to all that piece, parcel or tract of land situate in said County and State on the White Horse Road containing forty (45 1/2) five and one-half acres, more or less, bounded by lands of Frank Cunningham, Berry, Martin and others, being the same lands conveyed to said Peter F. Sudduth by Elizabeth Dawson by deed bearing date the 26th. of October A.D. 1883 and recorded in P.M.C. office Book O.O. page 670, a fuller description of said land being found in a deed by Elizabeth R. Johnson to Sallie F. Earle the 6th. day of December 1880 and recorded in Book L.L. page 93.
